#### **Community Bulletin Board**




To post a flyer on the community bulletin board at the mail building, you can either put it in the DW2 drop box and I will post your flyer or you can try opening up the case. It

#### Street Sweeping begins November 1st

Street sweeping will begin Wednesday, November 1st (weather dependent) and last for the remainder of the week. Please do not park on the street. Your help in removing leaves and needles in front of your residence will help reduce the time the street sweeper will be on



#### 2024 Budget Hearing

The Board reviewed the proposed 2024 Budget at the October 18th Budget Hearing board meeting. No residents attended. The budget has \$793,768 total revenues and \$816,729 total expenditures with an expected deficit of \$22,961. It contains another increase (5%) in Lake Durango Water authority water rates. The 2024 Budget will be adopted, according to state law, at the November meeting.

#### **Prevent Sewer Line Clogs**

Everything you put down the toilet ends up in the sewer pipes and sewer mains which can cause back-ups at your home and in the



system. DO NOT flush anything down except human waste and regular toilet paper. Do NOT flush baby wipes, wet wipes, tampons, dental floss, or facial tissues. Even if baby wipes/ wet wipes say 'flushable', they should go in the trash. When wet wipes and other items meet up in the collection system with oil and grease, there's a log jam causing backups or clogs

in the collection system. Do not flush cat pee or poop from your kitty litter box down the toilet. Items not to flush include: Baby Wipes, Dental Floss, Q-tips, Cotton Balls, Diapers, Condoms, Paper Towels, Napkins, Papers, Medication, Cigarettes, Coffee Grounds.

#### **District Property**

Do not take dirt, sand, or other materials from the end of Aspen Drive. It is district property that we have paid for and is to be used for water breaks and bedding pipes. We ask that parents have a conversation with their children and teens about respecting district trails and property. There have been a few recent incidents of neighborhood kids removing sand from the pile to build jumps or play with in other ways.

#### **HOA vs Special District**

A metro district is a local government entity that provides public services and infrastructure to a community. A homeowner's association (HOA) is a private organization that manages and enforces rules and regulations within a particular residential community.

Durango West Metro District 2 is a special district within the state of Colorado. It is not an HOA. The district provides water, sewer collection and wastewater treatment services, and maintenance of roads and open space. It charges fees for these services. It is not an HOA and therefore does not manage or enforce covenants or perform other typical HOA functions.

#### **Pond Projects in November**

The board approved projects around the main pond to clean up the cattails and to improve the culvert and drainage leading into the pond area. The contractor will begin mobilizing in November – date TBD. He estimates that the projects will take seven working days, weather permitting. They will have an excavator and a skid steer operating along with roll-off dumpsters being hauled in & out; and say that the noise will not be too loud. There will be temporary disturbance to the water and therefore likely increased odors associated with that. #### **Pedestrian Precautions**

Residents walking or running should do so facing oncoming traffic, according to various websites including the National Traffic Highway Safety Administration. As it is getting dark earlier, residents should take extra precautions when walking around the neighborhood. Pedestrians should wear brightly colored clothing or have reflectors on their clothing or shoes to help them stand out to motor vehicle drivers. This could include a handheld flashlight or some type of light that attaches to their body. Sometimes, pedestrians wear hats with lights attached or some type of blinking light attached to clothing.

#### **Accessibility of District Utilities and Traffic Signs**



Reminder to all residents who have District traffic signs or facilities on an easement on your property, including sewer manholes, water curb stops, and fire hydrants: you must maintain adequate access to these facilities. Manholes, fire hydrants and water valves are not to be covered in landscaping which includes bushes, tree branches, etc. or enclosed by fencing.

#### **Respect Our Bears**

Keep our neighborhood and our bear neighbors safe by not providing easy food access.



Bears deserve Bears are out and looking for even **RESPECT NOT** more food on their quest to fatten up for winter. Do NOT leave birdfeeders or pet food dishes out at night. Do NOT leave your trash

can out before the morning of pick-up. Residents must either leave their trash containers in a garage until the day of pick-up and put the container back inside by the end of the day or have a bearproof garbage container. La Plata County has an ordinance that fines residents at least \$200 for not securing trash containers from wildlife. To report a violation, contact Animal Protection through Central Dispatch 970-385-2900. Reporting incidents of trash being allowed to be accessed by bears is very important to make our area safe for both bears and people.

#### No Parking on Streets

Parking on District streets is prohibited anytime under Resolution 2004-03. It seriously impedes our maintenance efforts. Residents and guests need to park vehicles including RVs in your private driveways and off the street. Owners who rent need to tell their renters not to park on the street and monitor the situation.



#### Road Right of Way

A reminder to residents to keep in mind the district Right of Way (ROW) policy when landscaping or considering any changes to their property that borders the road and is within 10-15 feet of the edge of the road. #### Free Chipping A Success!



Durango Fire and Rescue used their new grantfunded chipper to provide free curbside chipping service to DW2 residents. It was their first neighborhood chipping event and they said DW2 will serve as a model! This opportunity was made possible by the

Colorado State Forest Service, which funded the chipper/dump trailer through a Forest Restoration and Wildfire Risk Mitigation (FRWRM) grant. A crew of six completed the chipping in less than three days. Residents - please make sure you have cleaned any remaining materials from in front of your curb. Thank you.

Durango Fire and Rescue's grant runs on a five year cycle with many other area subdivisions to serve before returning here. They indicated that hopefully they will be back here within a few years.
